

AN ORDINANCE RELATING TO THE ADOPTION OF AN OFFICIAL FLAG  
FOR NELSON COUNTY, KENTUCKY

NOW THEREFOR, BE IT ORDAINED BY THE FISCAL COURT OF NELSON  
COUNTY KENTUCKY, AS FOLLOWS:

SECTION 1. That an official flag be designed for Nelson  
County, Kentucky, to be used at all ceremonies in connection  
with government business and such other public exposure and  
public buildings as the Court may from time to time direct.

SECTION 2. By and through the Nelson County Fiscal Court, the  
official flag for Nelson County be and is hereby adopted and  
described as follows: Such flag shall consist of three  
vertical stripes being in color from left to right - blue,  
white and red and shall contain a circular crest in the center  
evenly balanced between the two ends, with crest shall contain  
a picture of Nelson County with the words "Nelson County"  
above the photo and "Heart of Kentucky" below the photo.

SECTION 3. That the within flag shall be afforded all the  
respect and formality in conformity with the flag of the  
United States of America.

SECTION 4. That all aordinances, resolutions, orders and parts  
hereof in conflict herewith are hereby repealed to the extent  
of such conflict, and this Ordinance, Order and Resolution  
shall take effect and be in force upon publication as required  
by law.

AN ORDINANCE OF THE FISCAL COURT OF THE COUNTY OF NELSON, KENTUCKY, RELATING TO THE AUTHORIZATION AND IMPLEMENTATION OF A BAN ON ALL OPEN BURNING DURING PERIODS OF HAZARDOUS FIRE CONDITIONS.

NOW THEREFORE, BE IT AND IT IS HEREBY ORDAINED BY THE FISCAL COURT OF THE COUNTY OF NELSON, KENTUCKY, AS FOLLOWS:

Section 1. As provided in KRS 149.401, upon notice by the division of forestry of the Commonwealth of Kentucky, that a period of extraordinary forest fire hazard or fire occurrence exists within the territorial limits of Nelson County, Kentucky, the County Judge/Executive is hereby authorized by executive order to ban all open burning in Nelson County during the existence of such conditions.

Section 2. Upon the issuance of such executive order, the same shall be in force and effect of law and may be enforced by the County or its' agents the Cabinet for Natural Resources and Environment Protection, and referred to the County Attorney for the Commonwealth Attorney for prosecution.

Section 3. Any physically able resident of this state above the age of eighteen (18) who refuses or neglects to assist in extinguishing forest fires, when summoned by a warden as authorized by KRS 149.090(2), and any person who refuses to allow the use of required equipment or materials authorized by KRS 149.090(3), shall be fined not less than fifty (50) nor more than five hundred (\$500).

Section 4. That all ordinances, resolutions, orders or parts thereof in conflict with the provisions of this Ordinance are, to the extent of such conflicts, hereby repealed.

Section 5. That this Ordinance shall become effective upon its passage and approval on its second reading and a publication of the summary thereof as required by law.

Introduced and given first reading at a duly convened meeting of the Fiscal Court of Nelson County, Kentucky, held on August 18, 1987.

Given second reading and adopted at a duly conveyed meeting of the Fiscal Court of Nelson County, Kentucky, held on September 1, 1987.

Adopted this 1st day of September, 1987, by a vote of 6 ayes and 0 nays.
